

## **\*\*The नेपाल Special FX Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the नेपाल Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to नेपाल.

The Promotion will be valid for qualifying transfers submitted during the Promotion Period and must successfully complete to be eligible for the Special FX Rate.
