

The আলজেরিয়া Special FX Promotion

Terms and Conditions:

- To be eligible for আলজেরিয়া Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to আলজেরিয়া.

- **The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.**

- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion. The Qualifying Transfer must be Successfully Completed to be eligible for the Special FX Rate.
