

The কোত দিভোয়ার Special FX Promotion

Terms and Conditions:

- To be eligible for কোত দিভোয়ার Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to কোত দিভোয়ার.
