

## The স্নোভাকিয়া Special FX Promotion

### Terms and Conditions:

- To be eligible for স্নোভাকিয়া Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to স্নোভাকিয়া.
