

****The Three 0-fees Transactions Promotion****

****Terms and Conditions:****

- To be eligible for the Three (3) 0-Fees Transactions promotion (“Promotion”) you must sign up for the first time via the screen which linked you to these terms and successfully complete your first three (3) transfers during the Promotion Period as more fully described in the Promotion messaging that linked you to these terms (each such successfully completed transfer is a “qualifying transfer”).

- This Promotion is available to customers in each of the “Eligible Send Countries” specified below to make a qualifying transfer to each respective “Eligible Receive Country” as specified below, and is subject to change in Remitly’s sole discretion.

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient, and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered “successful” transactions.

- 0-Fee Transfers do not apply to transactions made with credit cards.

- The Promotion begins on July 31st, 2025, at 12:00 PM [Pacific Time] and ends at 11:59 PM [Pacific Time] on September 22nd, 2025. Remitly’s server is the official clock for this Promotion. All dates are subject to change. Transfers

submitted outside of the Promotion Period will not be eligible for this Promotion.
