

## **\*\*The কানাডা to এল সালভাদোর Special FX + Two (2) 0-Fees Transaction Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the কানাডা to এল সালভাদোর Special FX + Two (2) 0-Fees Transaction promotion (“Promotion”) you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from কানাডা to এল সালভাদোর during the Promotion Period (a “qualifying transfer”).

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). - The special foreign exchange rate will be applied by Remitly directly to your first qualifying transfer up to \$500 (the "Promotion Cap").

- Amounts sent in excess of the Promotion Cap will be sent at the foreign exchange rate normally applicable to the service selected by you at the time of the your transaction.

- The Two (2) 0 fee transfer(s) will be directly applied to your first two (2) successfully completed transactions.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.
