

****The স্পেন to কলম্বিয়া Special FX + Two (2) 0-Fees Transaction Promotion****

****Terms and Conditions:****

- To be eligible for the স্পেন to কলম্বিয়া Special FX + Two (2) 0-Fees Transaction promotion (“Promotion”) you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from স্পেন to কলম্বিয়া during the Promotion Period (a “qualifying transfer”).
