

## **\*\*The স্নোভেনিয়া Special FX Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the স্নোভেনিয়া Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to স্নোভেনিয়া.
