

****The দক্ষিণ আফ্রিকা Special FX Promotion****

****Terms and Conditions:****

- To be eligible for the দক্ষিণ আফ্রিকা Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to দক্ষিণ আফ্রিকা.
