

****The মাল্টা Special FX Promotion****

****Terms and Conditions:****

- To be eligible for the মাল্টা Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to মাল্টা.
