

****The জিস্বাবুয়ে Special FX Promotion****

****Terms and Conditions:****

- To be eligible for the জিস্বাবুয়ে Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to জিস্বাবুয়ে.
