

****The ডোমিনিকান প্রজাতন্ত্র Special FX Promotion****

****Terms and Conditions:****

- To be eligible for the ডোমিনিকান প্রজাতন্ত্র Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to ডোমিনিকান প্রজাতন্ত্র.
