

# The Transfer Discount Offer Code Promotion

## Terms and Conditions:

- To be eligible for the Transfer Discount Offer Code promotion ("Promotion") you must redeem the respective transfer discount offer code via the notification from Remitly that linked you to these terms or enter the respective transfer discount offer code at a "Redeem Offer" or "Apply an Offer" page when signed in to your Remitly account and successfully complete a transfer during the Promotion Period as more fully described in the transfer discount offer code messaging that linked you to these terms (such successfully completed transfer is a "qualifying transfer").
- Transfer Discount Offer Code Conditions. After you redeem the respective transfer discount offer code for this Promotion, the respective transfer discount will be applied by Remitly directly to your next qualifying transfer if it is successfully completed during the Promotion Period. Please note that your discount amount will not count towards the minimum send requirements. The transfer discount cannot be used on subsequent transfers.
- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.
- The Promotion is available for customers who have received notification from Remitly about the Promotion and is limited to one (1) per person.
- This Promotion has no cash value and cannot be transferred.
- The Promotion Period for the respective transfer discount offer code begins on the date and time of the first notification from Remitly that linked you to these terms and ends on the date and time as more fully described in such notification ("Promotion Period"). Remitly's server is the official clock for this Promotion. All dates are subject to change. Transfers submitted outside of the

Promotion Period will not be eligible for this Promotion.

- Remitly reserves the right to (a) limit the number of individuals per household eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods will void and disqualify the customer from receiving the Promotion at Remitly's sole discretion (acting reasonably).

- If you are entitled to any refund, you will not be entitled to receive any amount greater than the amount you have paid to make the money transfer.
