

****The বসনিয়া ও হার্জেগোভিনা Special FX Promotion****

****Terms and Conditions:****

- To be eligible for the বসনিয়া ও হার্জেগোভিনা Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to বসনিয়া ও হার্জেগোভিনা.
