

## **\*\*The Canada to Ecuador Special FX + Two (2) 0-Fees Transaction Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the Canada to Ecuador Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from Canada to Ecuador during the Promotion Period (a "qualifying transfer").
- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.
- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.
  - Special FX conditions.
    - The special foreign exchange rate will be applied by Remitly directly to your first qualifying transfer up to \$500.00 (the "Promotion Cap").
    - If you send below the Promotion Cap, the special foreign exchange rate will not be applied on subsequent transfers.
    - Amounts sent in excess of the Promotion Cap will be sent at the foreign exchange rate normally applicable to the service selected by you at the time of the your transaction.
  - 0 fee transfer(s) conditions.
    - The Two (2) 0 fee transfer(s) will be directly applied to your first two (2) successfully completed transactions.
    - 0 Fee transfer(s) do not apply to transactions made with credit cards.
  - This Promotion has no cash value and cannot be transferred.
  - The Promotion begins on August 14, 2023 at 12:00 AM Pacific Standard Time and ends at 11:59 PM Pacific Standard Time on December 31, 2024 ("Promotion Period"). Remitly's server is the official clock for this Promotion. All dates are subject to change. Transfers submitted outside of the Promotion Period will not be eligible for this Promotion.
  - Remitly reserves the right to (a) limit the number of individuals per household eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive.
