

## **\*\*The Äthiopien Special FX Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- Special FX Rate Conditions. The Special FX Rate will be applied by Remitly directly to your qualifying transfer and cannot be used on subsequent transfers. The Special FX Rate is subject to change from time to time at Remitly's discretion. The Promotion will be valid for qualifying transfers submitted during the Promotion Period and must successfully complete to be eligible for the Special FX Rate.

- A transfer is considered "successfully completed" when funds are deposited into your intended recipient's bank account. If the transaction is not successfully completed, the Special FX Rate available at the time of initiation will not be applied to any future transfers.

- Amounts sent in excess of the Promotion Cap will sent at the FX Rate applicable to the service selected by you at the time of your transaction.

- All FX rates are subject to change from time to time at Remitly's discretion.
