

The Indien FX Boost + \$ Transfer Discount Promotion

Terms and Conditions:

- To be eligible for Australien to Indien FX Boost + \$ Transfer Discount Promotion ("Promotion") you must sign up for Remitly through Remitly's referral-branded landing page and successfully complete your first transfer to Indien (e.g., a "qualifying transfer").

If the transaction is not successfully completed, the Special FX Rate available at the time of initiation will not be applied to any future transfers.
