

****The Neuseeland to Philippines Special FX + Two (2) 0-Fees Transaction Promotion****

****Terms and Conditions:****

- To be eligible for the Neuseeland to Philippines Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from Neuseeland to Philippines during the Promotion Period (a "qualifying transfer").
