

The Sweden to Honduras 0 fees Transaction Promotion

Terms and Conditions:

- To be eligible for the Sweden to Honduras 0 fees Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's 0 fees transaction branded landing page and successfully complete your first transfer to **Honduras**.

- **The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.**

- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion. The purpose of this restriction is to prevent fraud or abuse of the promotion by customers. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods, will void and disqualify the customer from receiving the Promotion at Remitly's sole discretion.

- The Promotion will entitle eligible customers to make one (1) transfer to **Honduras** without transaction fees on your first transfer (the "qualifying transfer").

- **0 fees Transfer Conditions.** The 0 fees transfer will be directly applied to your first successfully completed transaction during the Promotion Period. Transfers submitted outside of the Promotion Period will not be eligible for a 0 fees transfer. 0 fees transactions do not apply to transactions made with credit cards.

- A transfer is considered "successfully completed" when funds are deposited into your intended recipient's bank account or are picked up by your recipient at a cash pick-up location.

- Your election to participate in the Promotion will render you ineligible for participation in other promotions that Remitly may run and that you may otherwise have been eligible for. Your election to participate in the Promotion is final.

- The Promotion will be valid for qualifying transfers submitted during the Promotion Period. The "Promotion Period" begins on November 18, 2019 at 2:52 PM Irish Standard Time and ends at 12:00 AM Irish Standard Time on December 31, 2020. Remitly's server is the official clock for the Promotion.

- Insufficient funding of your transfer will render you ineligible for the Promotion. The Promotion will not be valid for any otherwise qualifying transaction that is cancelled either by you or by Remitly.

- **This is a limited time offer.** Remitly reserves the right to cancel the Promotion at any time, with or without prior notice and also extend the above Promotion Period. Any qualifying transfer will be honored if initiated prior to the Promotion's cancellation.
