

## Terms and Conditions:

### The Verenigde Staten to 0 Fee Transaction and Transfer Discount Promotion

#### Terms and Conditions:

- To be eligible for the promotion ("Promotion") you must sign in via the screen which linked you to these terms and successfully complete a transfer to during the Promotion Period (a "qualifying transfer").

- **0 fee transfer(s) conditions.**

- The 0 fee transfer will be directly applied to your first successfully completed transaction.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.

#### Transfer discount conditions.

- The transfer discount will be applied by Remitly directly to your second successfully completed qualifying transfer.

- Please note that your discount amount will not count towards the minimum spend requirements.

- The transfer discount cannot be used on subsequent transfers.

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the cash sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The transfer discount cannot be used on subsequent transfers.

- **The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.**

- This Promotion has no cash value and cannot be transferred.

- The Promotion begins on at PST and ends at PST on ("Promotion Period"). Remitly's server is the official clock for this Promotion. All dates are subject to change. Transfers submitted outside of the Promotion Period will not be eligible for this Promotion.

- Remitly reserves the right to (a) limit the number of individuals per household eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods will void and disqualify the customer from receiving

the Promotion at Remitly's sole discretion (acting reasonably).

- If you are entitled to any refund, you will not be entitled to receive any amount greater than the amount you have paid to make the money transfer.

- Your election to participate in this Promotion will render you ineligible for participation in other promotions that Remitly may run and that you may otherwise have been eligible for. Your election to participate in this Promotion is final.
