

## **The Vereinigte Staaten to Nikaragua Fee-Free on First Transfer + Discount on Second Transfer Promotion**

### **Terms and Conditions:**

- To be eligible for the Vereinigte Staaten to Nikaragua Fee-Free on First Transfer + Discount on Second Transfer promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer and second transfer from Vereinigte Staaten to Nikaragua during the Promotion Period (each a "qualifying transfer").

- Once you have successfully completed your first qualifying transfer, The \$5 transfer discount will be applied by Remitly directly to your second successfully completed qualifying transfer when you send \$30 or more .

- Please note that your discount amount will not count towards any minimum spend requirements.

- The transfer discount cannot be used on subsequent transfers.
