

## **\*\*The Brazil Special FX Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the Brazil Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to Brazil.

- Special FX Rate Conditions. The Special FX Rate will be applied by Remitly directly to your qualifying transfer and cannot be used on subsequent transfers.
