

## **\*\*The Egypt Special FX Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- Special FX Rate Conditions. The Special FX Rate will be applied by Remitly directly to your qualifying transfer and cannot be used on subsequent transfers. The Promotion will be valid for qualifying transfers submitted during the Promotion Period and must successfully complete to be eligible for the Special FX Rate.
