

****The Mozambique Special FX Promotion****

****Terms and Conditions:****

- To be eligible for the Mozambique Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to Mozambique.

- The Promotion is available for first time customers only and is limited to one (1) per person. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.
