

****The Somalia Special FX Promotion****

****Terms and Conditions:****

- To be eligible for the Somalia Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to Somalia.

- Special FX Rate Conditions. The Special FX Rate will be applied by Remitly directly to your qualifying transfer and cannot be used on subsequent transfers. The Special FX Rate is subject to change from time to time at Remitly's discretion. The Promotion will be valid for qualifying transfers submitted during the Promotion Period and must successfully complete to be eligible for the Special FX Rate.

- Amounts sent in excess of the Promotion Cap will sent at the FX Rate applicable to the service selected by you at the time of your transaction.

- All FX rates are subject to change from time to time at Remitly's discretion.
