

****The 0-Fees on First Transfer and Special FX Rate on First 2 Transfers Promotion****

****Terms and Conditions:****

- To be eligible for the 0 Fees on First Transfer and Special FX Rate on First 2 Transfers promotion ("Promotion") you must sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer and second transfer during the Promotion Period as more fully described in the Promotion messaging that linked you to these terms (each such successfully completed transfer is a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient, and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The 0 fee transfer will be directly applied to your first successfully completed transaction.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.

Special FX Rate conditions:

- The special foreign exchange rate will be applied by Remitly directly to your first two (2) qualifying transfers up to the promotion cap as stated on the Promotion page or messaging, which linked you to these terms (the "Promotion Cap").
