

The Australia to India Zero-fee Transaction Promotion

Terms and Conditions:

- To be eligible for the Australia to India Zero-fee Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's zero-fee transaction-branded landing page and successfully complete your first transfer to India.
- The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.
- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods, will void and disqualify the customer from receiving the Promotion at Remitly's sole discretion.
- The Promotion will entitle eligible customers to make one (1) transfer without transaction fees on their first transfer to India (the "Qualifying Transfer").
- 0-Fee Transfer Conditions. The 0-fee transfer will be directly applied to your first successfully completed transaction during the Promotion Period. Transfers submitted outside of the Promotion Period will not be eligible for a 0-fee transfer. Zero-fee transactions do not apply to transactions made with credit cards.
- A transfer is considered "Successfully Completed" when funds are deposited into your intended recipient's bank account [or the cash sent is picked up by the recipient at one of our partner locations].
- Your election to participate in the Promotion will render you ineligible for participation in other promotions that Remitly may run and that you may otherwise have been eligible for. Your election to participate in the Promotion is final.
- The Promotion will be valid for qualifying transfers submitted during the Promotion Period. The "Promotion Period" begins on July 1, 2018 at 9:00 a.m Australian EST and ends on April 1, 2019 at 11:59 p.m Australian EST. Remitly's server is the official clock for the Promotion.
- Insufficient funding of your transfer will render you ineligible for the Promotion. The Promotion will not be valid for any otherwise qualifying transaction that is cancelled either by you or by Remitly.
