

****The Canada to India Special FX + Two (2) 0-Fees Transaction Promotion****

****Terms and Conditions:****

- To be eligible for the Canada to India Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from Canada to India during the Promotion Period (a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.

- The special foreign exchange rate will be applied by Remitly directly to your first qualifying transfer up to \$2000 (the "Promotion Cap").
