

## **\*\*The 0-fee + Special FX + Discount Transfer Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the 0-fee + Special FX + Discount Transfer promotion ("Promotion") you must sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer during the Promotion Period as more fully described in the Promotion messaging that linked you to these terms (such as successfully completed transfer is a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient, and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.

#### **0-Fee transfer conditions:**

- The 0 fee transfer will be directly applied to your first successfully completed transaction.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.

#### **Special FX Rate conditions:**

- The special foreign exchange rate will be applied by Remitly directly to your first qualifying transfer up to the promotion cap as stated on the Promotion page or screen which linked you to these terms (the "Promotion Cap"). If you are a UAE customer, the special foreign exchange rate will be applied by Remitly's partner bank (itself licensed by the Central Bank of the United Arab Emirates).

- If you send below the Promotion Cap, the Special FX Rate will not be applied on subsequent transfers.

- Amounts sent in excess of the Promotion Cap will be sent at the foreign exchange rate normally applicable to the service selected by you at the time of your transaction. FX rates are subject to change from time to time at Remitly's discretion.

- The transfer discount will be applied by Remitly to your first qualifying transfer and will be available only to that transfer if it meets any required minimum spend requirement as described on the screen which linked you to these terms and if it is successfully completed during the Promotion Period.
