

# **The 0 Fee Transfer(s) Remitly Business Promotion**

## **Terms and Conditions:**

- To be eligible for the 0 Fee Transfer(s) Promotion ("Promotion") you must successfully complete a transfer(s) during the Promotion Period as more fully described in the 0 fee transfer messaging that linked you to these terms (such successfully completed transfer is a "qualifying transfer").
- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.
- The Promotion is available for customers who have received notification from Remitly about the Promotion and is limited to one (1) per Remitly Business customer.
- 0 Fee transfer(s) Promotion conditions. The Promotion will be directly applied to your next qualifying transfer(s), as more fully described in the 0 fee transfer Promotion messaging that linked you to these terms, including as to the number of qualifying transfers.
- 0 Fee transfer(s) do not apply to payment method fees for transactions made with credit or debit cards.
- This Promotion has no cash value and cannot be transferred.
- The Promotion Period for the respective 0 fee transfer(s) begins on the date and time of the first notification from Remitly that linked you to these terms and ends on the date and time as more fully described in such notification ("Promotion Period"). Remitly's server is the official clock for this Promotion. All dates are subject to change. Transfers submitted outside of the Promotion Period will not be eligible for this Promotion.
- Remitly reserves the right to (a) limit the number of individuals per household or business eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods will void and disqualify the customer from receiving the Promotion at Remitly's sole discretion (acting reasonably).
- If you are entitled to any refund, you will not be entitled to receive any amount greater than the amount you have paid to make the money transfer.
- Your election to participate in this Promotion will render you ineligible for participation in other promotions that Remitly may run and that you may otherwise have been eligible for. Your election to participate in this Promotion is final.
