

## **\*\*New Customer Offer Terms and Conditions\*\***

- The specific promotion available to you is set out in the promotional messaging that directed you to these terms (the "Applicable Promotion"). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.
