

## **\*\*New Customer Offer Terms and Conditions\*\***

- The specific promotion available to you is set out in the promotional messaging that directed you to these terms (the "Applicable Promotion"). - For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient, and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Applicable Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible.
