

The United Kingdom to Honduras Special FX + 0 Fee Transaction Promotion

Terms and Conditions:

- To be eligible for the United Kingdom to Honduras Special FX + 0 Fee Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to Honduras.

- **The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.**

- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods, will void and disqualify the customer from receiving the Promotion at Remitly's sole discretion.

- The Promotion will entitle eligible customers to: (i) make one (1) transfer without transaction fees on your first transfer (the "qualifying transfer"); and (ii) make one (1) transfer of up to £1000 to Honduras at the foreign exchange rate (the "Special FX Rate") published on Remitly's Special FX branded landing page or mobile application that linked to these Terms and Conditions, as that rate was published at the time that the qualifying transaction is submitted by you.

- **0 Fees Transfer Conditions.** The 0 fees transfer will be directly applied to your first successfully completed transaction during the Promotion Period. Transfers submitted outside of the Promotion Period will not be eligible for a 0 fees transfer. 0 fees transactions do not apply to transactions made with credit cards.

- **Special FX Rate Conditions.** The Special FX Rate will be applied by Remitly directly to your qualifying transfer up to the Promotion Cap. The Special FX Rate is valid for qualifying transfers submitted during the Promotion Period and must successfully complete to be eligible for the Special FX Rate. If you send below the Promotion Cap, the Special FX Rate will not be applied on subsequent transfers.

- A transfer is considered "successfully completed" when funds are deposited into your intended recipient's bank account or are picked up by your recipient at a cash pick-up location. If the transaction is not successfully completed, the Special FX Rate available at the time of initiation will not be applied to any future transfers.

- Amounts sent in excess of the Promotion Cap will sent at the FX Rate applicable to the service selected by you at the time of your transaction.

- All FX rates are subject to change from time to time at Remitly's discretion.

- Your election to participate in the Promotion will render you ineligible for participation in other promotions that Remitly may run and that you may otherwise have been eligible for. Your election to participate in the Promotion is final.

- The Promotion will be valid for qualifying transfers submitted during the Promotion Period.
