

****The 0-fee on First Transfer + Discount on Second Transfer Promotion****

****Terms and Conditions:****

- To be eligible for the 0-fee on First Transfer + Discount on Second Transfer promotion (“Promotion”) you must sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer and second transfer during the Promotion Period as more fully described in the Promotion messaging that linked you to these terms (each such successfully completed transfer is a “qualifying transfer”).

- The 0 fee transfer will be directly applied to your first successfully completed transaction.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.

Transfer discount conditions

- After you’ve successfully completed your first qualifying transfer, the transfer discount will be applied by Remitly to your next qualifying transfer and will be available only to that transfer if it meets any required minimum spend requirement as described on the screen which linked you to these terms and if it is successfully completed during the Promotion Period.
