

## **\*\*New Customer Offer Terms and Conditions\*\***

- The specific promotion available to you is set out in the promotional messaging that directed you to these terms (the "Applicable Promotion"). To be eligible for the Applicable Promotion, you must sign up for the first time via the promotion-related screen which linked you to these terms and successfully complete one or more transfers during the Promotion Period as more fully described in the Applicable Promotion (such successfully completed transfer is a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient, and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Applicable Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible.
