

## **\*\*Remitly Business Two (2) Transfer Discount Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the Remitly Business Two (2) Transfer Discount promotion ("promotion") you must sign up for the first time via the screen which linked you to these terms and successfully complete your first and second transfers during the Promotion Period as more fully described in the promotional messaging linking you to these terms, including any minimum spend requirements (each such successfully completed transfer is a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient, and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Promotion is available for first-time Remitly Business customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.

### **Transfer discount conditions:**

- The promotion will be applied by Remitly directly to your qualifying transfers. The promotion will be applied to your transfers only if they meet any minimum spend requirement as described in the promotional messaging that linked you to these terms and if they are successfully completed during the Promotion Period.

- Please note that your promotion amount will not count towards any minimum spend requirements.

- The transfer discount cannot be used on further subsequent transfers.

- This Promotion has no cash value and cannot be transferred.

- The Promotion Period for a respective transfer discount offer code begins and ends on the dates/times as more fully described in the transfer discount offer code messaging that linked you to these terms (each respective promotion period is a "Promotion Period"). Remitly's server is the official clock for this Promotion. All dates are subject to change. Transfers submitted outside of the Promotion Period will not be eligible for this Promotion.

- Remitly reserves the right to (a) limit the number of individuals per household eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods will void and disqualify the customer from receiving the Promotion at Remitly's sole discretion (acting reasonably).

- If you are entitled to any refund, you will not be entitled to receive any amount greater than the amount you have paid to make the money transfer.

- Your election to participate in this Promotion will render you ineligible for participation in other promotions that Remitly may run and that you may otherwise have been eligible for. Your election to participate in this Promotion is final.
