"El Clasico with Remitly Sweepstakes" Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT IMPROVE CHANCES OF WINNING.

1\. ELIGIBILITY. The "El Clasico with Remitly Sweepstakes" (the "Promotion") is open to individuals who successfully complete their first Remitly transaction from the United States during the Promotion Period as more fully described in these Official Rules or who enter the Promotion through the alternate method of entry ("AMOE") (each such entrant is an "Entrant").

Entrants must be legal residents of the 50 United States or the District of Columbia ("U.S.") and be the older of 18 years of age or the legal age of majority in their state of residence at time of entry. Entrant's participation in the Promotion constitutes agreement to these Official Rules. Employees of Remitly, Inc.
