

The Transfer Discount Promotion

Terms and Conditions:

- To be eligible for the Transfer Discount Promotion (“Promotion”) you must successfully complete a transfer during the Promotion Period as more fully described in the transfer discount messaging that linked you to these terms (such successfully completed transfer is a “qualifying transfer”).

- **Transfer Discount Conditions.** The transfer discount will be applied by Remitly directly to your next qualifying transfer and will be available only to that transfer if it is successfully completed.

- Please note that your discount amount will not count towards the minimum spend requirements.

- The transfer discount cannot be used on subsequent transfers.

- For a transfer to be considered “successfully completed”, the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered “successful” transactions.

- The Promotion is available for customers who have received notification from Remitly about the Promotion and is limited to one (1) per person.

- This Promotion has no cash value and cannot be transferred.

- The Promotion Period for a respective transfer discount begins on the date and time of the first notification from Remitly that linked you to these terms and ends on the date and time as more fully described in such notification (“Promotion Period”). Remitly’s server is the official clock for this Promotion. All dates are subject to change. Transfers submitted outside of the Promotion Period will not be eligible for this Promotion.

- Remitly reserves the right to (a) limit the number of individuals per household eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods will void and disqualify the customer from receiving the Promotion at Remitly’s sole discretion (acting reasonably).

- If you are entitled to any refund, you will not be entitled to receive any amount greater than the amount you have paid to make the money transfer.

- Your election to participate in this Promotion will render you ineligible for participation in other promotions that Remitly may run and that you may otherwise have been eligible for. Your election to participate in this Promotion is final.

- Cancellation or insufficient funding of your transfer will render you ineligible for this Promotion. This Promotion will not be valid for any transfer that is cancelled either by you or by Remitly.

- You may not participate in the Promotion where doing so would be prohibited by any applicable law, statute or regulations.

- Remitly reserves the right to cancel the Promotion at any time, with or without prior notice. Any qualifying transfer will be honored if initiated prior to the Promotion's cancellation.
