

The United States to Hong Kong Two (2) 0-Fees Transaction Promotion

Terms and Conditions:

- To be eligible for the United States to Hong Kong Two (2) 0-Fees Transaction promotion ("Promotion") you must sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer to Hong Kong during the Promotion Period ((a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.

- **0 fee transfer) conditions.** The 0-fee transfer will be directly applied to your first two (2) successfully completed transactions. 0 Fee transfer(s) do not apply to transactions made with credit cards.

- This Promotion has no cash value and cannot be transferred.

- The "Promotion Period" begins on November 24th 2025 at 10:00 AM Pacific Standard Time and ends at 10:11 AM Pacific Standard Time on December 30th 2026.
