

## **\*\*The 0-Fees on First Transfer and Special FX Rate on First 2 Transfers Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the 0 Fees on First Transfer and Special FX Rate on First 2 Transfers promotion (“Promotion”) you must sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer and second transfer during the Promotion Period as more fully described in the Promotion messaging that linked you to these terms (each such successfully completed transfer is a “qualifying transfer”).

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient, and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered “successful” transactions.

- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.

#### **0-Fee transfer conditions:**

- The 0 fee transfer will be directly applied to your first successfully completed transaction.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.

#### **Special FX Rate conditions:**

- The special foreign exchange rate will be applied by Remitly directly to your first two (2) qualifying transfers up to the promotion cap as stated on the Promotion page or messaging, which linked you to these terms (the “Promotion Cap”). If you are a UAE customer, the special foreign exchange rate will be applied by Remitly's partner bank (itself licensed by the Central Bank of the United Arab Emirates)

- If you send below the Promotion Cap, the Special FX Rate will not be applied on subsequent transfers.

- Amounts sent in excess of the Promotion Cap will be sent at the foreign exchange rate normally applicable to the service selected by you at the time of your transaction. FX rates are subject to change from time to time at Remitly's discretion.

- This Promotion has no cash value and cannot be transferred.

- The Promotion begins on March 12th 2026 at 5:00 PM [Pacific Standard Time / Pacific Daylight Time] and ends at 4:59 PM [Pacific Standard Time / Pacific Daylight Time] on April 30th 2026 (“Promotion Period”). Remitly's server is the official clock for this Promotion. All dates are subject to change. Transfers submitted outside of the Promotion Period will not be eligible for this Promotion.

- Remitly reserves the right to (a) limit the number of individuals per household eligible for this Promotion; and (b) disqualify transfers that, in its opinion, are intended to circumvent Promotion rules, or are deemed to be abusive. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins, and/or any other methods will void and disqualify the customer from receiving the Promotion at Remitly's sole discretion (acting reasonably).

- If you are entitled to any refund, you will not be entitled to receive any amount greater than the amount you have paid to make the money transfer.
