

****The Special FX and 0-Fee on First Transfer + Discount on Second Transfer Promotion****

****Terms and Conditions:****

- To be eligible for the Special FX and 0-fee on First Transfer + Discount on Second Transfer promotion ("Promotion") you must sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer and second transfer during the Promotion Period as more fully described in the Promotion messaging that linked you to these terms (each such successfully completed transfer is a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient, and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). - The 0 fee transfer will be directly applied to your first successfully completed transaction.

- *Special FX Rate conditions.

- The special foreign exchange rate will be applied by Remitly directly to your first qualifying transfer up to the promotion cap as stated on the Promotion page or screen which linked you to these terms (the "Promotion Cap"). If you are a UAE customer, the special foreign exchange rate will be applied by Remitly's partner bank (itself licensed by the Central Bank of the United Arab Emirates).

- Amounts sent in excess of the Promotion Cap will be sent at the foreign exchange rate normally applicable to the service selected by you at the time of your transaction. FX rates are subject to change from time to time at Remitly's discretion.
