

The USA to the Philippines Transfer Bonus and Zero-fee Transaction Promotion

Terms and Conditions:

- To be eligible for the **USA to the Philippines** Transfer Bonus and Zero-fee Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's transfer bonus and zero-fee transaction-branded landing page and successfully complete your first transfer of \$ or more to the Philippines (i.e. a "qualifying transfer"). Please note that your bonus amount will not count towards the minimum spend requirements.

- A transfer is considered "successfully completed" when funds are deposited into your intended recipient's bank account; are picked up by your recipient at a cash pick-up location; properly delivered to you and/or deposited into the recipient's mobile wallet (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- **The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer. This is a limited time offer.**

- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion. Any attempt by a customer to abuse this Promotion by using multiple/different identities, registrations, logins and/or any other methods will void and disqualify the customer from receiving the Promotion at Remitly's sole discretion.

- **Transfer Bonus Conditions.** Once you have submitted a qualifying transfer on your first transaction, Remitly will automatically apply the \$ bonus to and not charge the transaction fee of that transfer. The \$ transfer bonus and zero-fee transaction will be applied by Remitly directly to your qualifying transfer and will be available only to that transfer if it is successfully completed. Transfers submitted outside of the Promotion Period will not be eligible for this Promotio.

- Failure to send over \$ or more on your first transfer will render you ineligible for this Promotion or other promotions that may be run for first time customers.

- The transfer bonus and zero-fee transaction cannot be used on subsequent transfers. The transfer bonus and zero-fee transaction have no cash value.
