

****The Three 0-fees Transactions Promotion****

****Terms and Conditions:****

- To be eligible for the Three (3) 0-Fees Transactions promotion ("Promotion") you must sign up for the first time via the screen which linked you to these terms and successfully complete your first three (3) transfers during the Promotion Period as more fully described in the Promotion messaging that linked you to these terms (each such successfully completed transfer is a "qualifying transfer").

- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient, and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.

- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.

0-Fee transfer conditions

- The 0-fee transfer will be directly applied to your first three (3) successfully completed transactions.

- 0 Fee transfer(s) do not apply to transactions made with credit cards.

- This Promotion has no cash value and cannot be transferred.

- The Promotion begins on July 31st 2025 at 12:00 PM [Pacific Standard Time / Pacific Daylight Time] and ends at 11:59 PM [Pacific Standard Time / Pacific Daylight Time] on July 22nd 2025 ("Promotion Period").
