

## **\*\*The Emiratos Árabes Unidos to Filipinas Special FX + Two (2) 0-Fees Transaction Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the Emiratos Árabes Unidos to Filipinas Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from Emiratos Árabes Unidos to Filipinas during the Promotion Period (a "qualifying transfer").
