

## **\*\*Terms and Conditions:\*\***

- To be eligible for the Referred Friend Discount Promotion (“Promotion”) you must sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer during the Promotion Period as more fully described in the Promotion messaging that linked you to these terms (such as a successfully completed transfer is a “qualifying transfer”).
