

## **Terms and Conditions:**

To be eligible for the Reino Unido to Nigeria first transfer (0 fee + special FX) and second transfer (0 fee only) promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer to Nigeria during the promotion period (a "qualifying transfer").
