

The Ireland to las Filipinas 0 fees Transaction Promotion

Terms and Conditions:

- To be eligible for the Ireland to **las Filipinas** 0 fees Transaction promotion ("Promotion") you must sign up for Remitly via Remitly's 0 fees transaction-branded landing page and successfully complete your first transfer to **las Filipinas**.

- **The Promotion is available for first time customers only and is limited to one (1) per customer. Existing customers are not eligible for this promotion. This Promotion is not valid with any other offer.**

- Remitly reserves the right to limit the number of individuals per household eligible for this Promotion. The purpose of this restriction is to prevent fraud or abuse of the promotion by customers.
