

## **\*\*The Nueva Zelanda to India Special FX + Two (2) 0-Fees Transaction Promotion\*\***

### **\*\*Terms and Conditions:\*\***

- To be eligible for the Nueva Zelanda to India Special FX + Two (2) 0-Fees Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from Nueva Zelanda to India during the Promotion Period (a "qualifying transfer").
