****Terms and Conditions:****

- To be eligible for the Corea del Sur Special FX promotion ("Promotion") you must sign up for Remitly via Remitly's special FX rate-branded landing page and successfully complete your first transfer to Corea del Sur.

If you send below the Promotion Cap, the Special FX Rate will not be applied on subsequent transfers.
