

## **\*\*The Royaume-Uni to Special FX + Two (2) Fee-Free Transaction Promotion\*\***

- To be eligible for the Royaume-Uni to Special FX + Two (2) Fee-Free Transaction promotion ("Promotion") you must: sign up for the first time via the screen which linked you to these terms and successfully complete your first transfer from Royaume-Uni to during the Promotion Period (a "qualifying transfer").
- For a transfer to be considered "successfully completed", the transfer must be either deposited in your intended recipient's bank account or mobile wallet, properly delivered to the recipient and/or the money sent is picked up by the recipient at one of our partner locations (as the case may be). Transactions subject to a subsequent payment decline or chargeback are not considered "successful" transactions.
- The Promotion is available for first-time customers only and is limited to one (1) per person. Existing customers are not eligible for this Promotion.
- Special FX conditions.
  - The special foreign exchange rate will be applied by Remitly directly to your first qualifying transfer up to (the "Promotion Cap").

  - The Two (2) 0 fee transfer(s) will be directly applied to your first two (2) successfully completed transactions.
  - 0 Fee transfer(s) do not apply to transactions made with credit cards.
